She said the State Complex biomass project that will serve the Agency, State Police, and DEC, will improve energy conservation by using renewable resources.

She reported on the Adirondack Hamlets to Huts Trekking Initiative based in Saranac Lake. She said two groups successfully participated in the initial tours.

1) Committee Reports

a) Regulatory Programs Committee

On motion by Mr. Wilt, seconded by Dr. Dawson, the Board unanimously approved P2017-149, Karen and Peter Fardelmann, involving a variance to replace/ expand a single-family dwelling located within the shoreline setback in the Town of Franklin, Franklin County.

On motion by Mr. Wilt, seconded by (the second was not heard), the Board unanimously approved P2015-119, K&C Land Holding, LLC, as amended and clarified by staff, authorizing the establishment of a new commercial use excavation contracting business, including the construction of a new 6,000 square foot building with on-site wastewater treatment system and well water supply, use of an existing storage building, storage of construction equipment and materials, and site improvements for stormwater management, noise control and mitigation of off-site visual impacts in the Town of Fort Ann, Washington County.

b) State Land Committee

On motion by Mr. Ernst, seconded by Mr. Stegemann, the Board unanimously adopted the Eagle Point Public Campground UMP resolution on APSLMP conformance.

On motion by Mr. Wilt, seconded by Ms. Mahoney, the Board unanimously adopted the Brown Tract Pond Public Campground UMP resolution on APSLMP conformance.

On motion by Mr. Stegemann, seconded by Mr. Lussi, the Board unanimously adopted the Generic Campground UMP Amendment resolution on APSLMP conformance.

On motion by Mr. Wilt, seconded by Mr. Stegemann, the Board unanimously adopted the Grass River Wild Forest UMP resolution on APSLMP conformance.

Department staff presented a public draft of the Blue Ridge Wilderness UMP Amendment. The Department will seek public comment.

Department staff presented a public draft of the Hammond Pond Wild Forest UMP Amendment. The Department will seek public comment.

c) Public Awareness and Communication Committee

Mr. Thomas commented on the NYSDEC Overview of Adirondack Park Conservation Easements. He said the presentation was well done and very informative.

d) Park Policy and Planning Committee

On motion of Dr. Dawson, seconded by Mr. Wilt, the Agency unanimously accepted the DSEIS for the Town of Westport/ Consolidated Mortgages, LLC map amendment and authorized the amendment to proceed to public comment.

5) Public Comment

Craig Leggett, Town of Chester Supervisor, said his town has been working on two projects. He said he was working with Dan Kelleher on economic development, and with Robyn Burgess on updating the Town' land use law. He said Agency staff have been very helpful and he appreciated working with the Agency.

Mr. Delaney thanked the Board for welcoming him. He commented on the future of solar farms and their impact on local governments. He said future APSLMP amendments can reflect the Park's changing users.
