By letter dated December 8, 2020, the Agency granted you a postponement on the above-referenced matter until spring 2021 to allow you to appear before the Agency's Enforcement Committee in person, if possible. As discussed in a phone conversation on April 23, 2021, with Agency staff, the Agency's precautionary coronavirus protocols still require meetings to be conducted remotely at this time and for the foreseeable future.

The above-referenced enforcement matter is now scheduled before the Enforcement Committee at the Adirondack Park Agency meeting on June 10-11, 2021. This meeting will be conducted remotely. An Agency staff member will contact you closer to the hearing date to confirm the date and time of the hearing and provide details regarding the WebEx technology that will be used to host the meeting.

You are invited to appear through participation in the WebEx Event and make a statement to the Enforcement Committee. Any retained legal counsel or authorized representative(s) may also appear through participation in the WebEx Event and make a statement to the Enforcement Committee, provided you are also in attendance. At the meeting, Agency staff will have 30 minutes to present their case to the Enforcement Committee. Staff is preparing a slide presentation based on the facts contained in the record. You will then have 30 minutes to present your case, which also may include the aid of any presentation tools you wish to use during the hearing. Please note that any presentations made before the Committee must be based only on the record.
