1. CALL TO ORDER and 2. WELCOMING REMARKS

Chairperson Ernst called the meeting to order at 9:35 a.m. and welcomed everyone. Alan Belensz of Friends of Siamese Ponds spoke to the Board about the Barton Garnet Mine, saying that residents are asking that the Agency consider dust, noise, visual impacts, and water usage before approving any expansions to the mining operations.

7. Executive Director's Report

Executive Director Rice welcomed everyone. Executive Director Rice noted that the Board had a busy day ahead of them with several State land topics and two Regulatory Program presentations. Executive Director Rice noted that staff have been very busy this summer, however they did make time for a picnic with families and retirees, adding surprise at how competitive the volleyball and croquet matches were. Regarding staffing, Executive Director Rice thanked Rob Lore, outgoing Deputy Director, Regulatory Programs, for all of the work done for the Agency, adding that Rob Lore was a key proponent of electronic application submissions which the Agency now uses. Executive Director Rice mentioned the passing of Tim Barnett who, while working for The Nature Conservancy for many years, protected thousands of acres of the Adirondacks including great Camp Santanoni. Executive Director Rice ended with a public service announcement that the week of September 19 – 25 is Get There Green week in NYS and encouraged everyone to participate in any way possible.

State Land Committee

(1) State Land Report (Megan Phillips)

Deputy Director of Planning Megan Phillips followed up regarding a question posed during the July meeting about the terms "visitor use management," "carrying capacity" and "limits of acceptable change," and how they relate to one another. Deputy Director Phillips pointed board members to the Federal Visitor Use Management Framework guidebook, which includes a section (see Appendix A) on the History and Limitations of Previous Visitor Use Management frameworks and offered to make hard copies of this resource available to interested board members.

Deputy Director Phillips also shared that the Department has completed the proposal review process and is moving toward securing a contract for development of a plan to address issues in the Central High Peaks and also the Kaaterskill Clove area of the Catskills.

Deputy Director Phillips provided an update on work to mitigate the spread of round goby to Lake Champlain. APA has been a partner in a rapid response task force convened by the Lake Champlain Basin Program. The task force includes DEC, Canal Corp, US Fish and Wildlife Service, US Geological Survey, and government partners from Vermont and Quebec.

The Adirondack Road Salt Reduction Task Force members have produced a draft report detailing its recommendations which is currently being edited and formatted. Report recommendations speak to a variety of topics including water quality standards and monitoring protocols, to public education and outreach, ways to increase public transparency about salt purchases and usage, as well training programs to assist practitioners in reducing overall application rates through the adoption of BMPs. The final report is slated to be released later this year.

(1) Regulatory Programs Report (John Burth)

John Burth began his report stating that staff have continued to work through the field season while managing project application deadlines and issuing permits and noted the increase in the number of permits issued and applications noticed in the Environmental Notice Bulletin (ENB) compared to Summer 2021. Based on the number of applications the Agency continues to receive, it is anticipated that the number of permits issued will remain high.

John Burth also noted that additional application materials were recently received for P2021-0248 (Stackman) which are now available on the Agency's website. He reviewed the timeline of the application up to this date and noted that the new materials are currently under review and the Agency anticipates issuing a second Notice of Incomplete Permit Application soon.

(2) P2021-0046 - BR Project 1, LLC (Ariel Lynch)

Ariel Lynch gave a detailed overview and presentation of the project including review of jurisdiction, conclusions of law, a description and slides of the project location and the existing conditions, site history, proposed project details, visual analysis slides, public comment, review by others, and staff's recommendation and permit conditions.

Discussions followed regarding the bond holders and the decommissioning plan.

(3) P2021-0163 – Lyme Timber (Aaron Ziemann)

Aaron Ziemann gave a detailed overview and presentation of the project including review of jurisdiction, conclusions of law, project location and existing conditions, site history, proposed project details, visual analysis slides, public comment, review by others, and staff's recommendation and permit conditions.

Discussion followed regarding the timeframes and yields of this project, age of trees versus carbon sequestration, and possible quantification of timber harvesting in the Park and on easement lands. Potential for a presentation in the future by SUNY ESF or PSC staff was mentioned, as well as an offer from Lyme Timber to tour their forestlands.

A motion to approve was made by Ken Lynch, seconded by John Ernst. All were in favor.

a) Regulatory Programs

Dan Wilt reported that the committee had heard a report from John Burth.

On motion of Dan Wilt, seconded by Matt Tebo, the Agency voted unanimously to approve P2022-0046, BR Project1, LLC, located in the Town of Clifton, St. Lawrence County.

On motion of Dan Wilt, seconded by Ken Lynch, the Agency voted unanimously to approve P2022-0163, Lyme Timber Company, located in the Town of Lake Pleasant, Hamilton County.

b) State Land Committee

Ken Lynch reported that the committee had heard a report from Megan Phillips, had a presentation on Accessibility & State Lands by DEC, and APA, and a presentation summarizing the public comments received on Wild Forest Basic Guideline No. 4 – No Material Increase of Roads on Wild Forest Lands.

On motion of Ken Lynch, seconded by Benita Law-Diao, the Agency voted unanimously that the Inter-Agency Guidelines for Best Management Practices to Control Invasive Species on DEC-Administered Lands of the Adirondack Park conformed with the guidelines with the State Land Master Plan.

c) Administration Committee

On motion from Chairperson Ernst, seconded by Brad Austin, the Agency unanimously adopted the Draft Policy Authorizing the Use of Videoconference for Agency meetings.
